

RECOMMENDATIONS OF THE COMMISSION

- **Maintain full payment of the annual actuarially determined employer contribution amount.**
- **Establish a Central Investment Office.**
- **Establish policies at both system boards that favor and encourage open public reporting best practices, and enact legislation to increase public reporting of all investment expenses.**
- **Move to fully index all public market investments in both equities and fixed income at both retirement systems.**
